Honest broker data analysts are able to retrieve data related to patient demographics, clinical encounter details, diagnoses, procedures, lab results, medications, patient pain scores, adult health literacy assessments, comorbidities, nursing assessments, genotyping data, bio-specimen availability and patient consent for research contact.
